

Why are you even registering your trademark in the US?

Is it really worth it?





It's what we do after all!

WHY register a trademark with the USPTO?

You'll gain *legitimate* legal ownership over your brand, products and services



Registered trademarks are easier to protect and defend

Trademarks are a valuable economic asset that appreciate over time



Wait!







You must follow the rules to register successfully

POPULAR NICE CLASSES:

- Class 9: Electrical and Scientific Apparatuses
- Class 25: Clothing
- Class 35: Advertising and Business Services
- Class 41: Education and Entertainment
- Class 42: Science and Technological Services



Your application must include:

- Name, Address, Business type
- An overview of your relevant products/services
- Basis for filing
- Drawing and description of the mark
- All applicable fees

If in commerce:

- Date of first use of trademark
- Proof of use for one product or service per class
- Verified statement of use or intention to use





Application process

Prepare and submit
paperwork to the
USPTO

Examine reviews application and either

- Receive an office action
- Proceed to next steps

 Mark established and public notified

• If *intent to use* and *no* opposition, mark can be used in commerce


Receive certificate of registration!

\$400 per class!



Reduced Fee options



Trademark Electronic Application System (Reduced Fee)

- Registration filing at a reduced fee acts as an incentive to file electronically
- **\$275** per class
- All correspondence via email and documentation submission will be online

TEAS Plus

Trademark Electronic Application System Plus

- **\$225** per class
- Certain conditions must be met:
 - Email correspondence only
 - Electronic submissions only
 - Filing complete application with no empty fields
 - All fees must be paid upfront



What factors will the examiner look for on your application?

Completeness

Compliance

OFFICE ACTIONS:

missing or inaccurate information on your application

You have six months –


HURRY UP and CORRECT!

Get help from a *professional* and do your search in advance



Trademark searches will prevent you from:







On WHAT grounds can people oppose you?

- Likelihood of confusion: marks are too similar
- Desired mark is likely to cause dilution of distinctiveness for their brand
- Non-compliance with application requirements
- Date of first use dispute







HOW long does the process take?


It takes about *six* to *nine* months
BUT if there are office actions and oppositions, it can take much *longer*



- You get a certificate of registration
- You're safe for 10 years!
- Monitor and police your trademark
